ORDINANCE NO. 08-62

**AN ORDINANCE CONCERNING THE INAUGURATION DATE OF THE VILLAGE
OF SAUK VILLAGE'S ELECTED OFFICERS**

WHEREAS, pursuant to Section 3.1-10-15 of the Illinois Municipal Code (the "Code"), as amended by Public Act 95-245 effective August 17, 2007, the terms of elected municipal officers shall commence at the first regular or special meeting of the corporate authorities after receipt of the official election results from the county clerk of the regular municipal election at which the officers were elected, except as otherwise provided by ordinance fixing the date for inauguration of newly elected officers of a municipality; and

WHEREAS, prior to its amendment, Section 3.1-10-15 of the Code provided that the terms of elected municipal officers commenced at the first regular or special meeting of the corporate authorities during the month of May following the proclamation of the results of the regular municipal election at which the officers were elected, unless otherwise fixed by ordinance; and

WHEREAS, the Mayor and Board of Trustees of the Village of Sauk Village (the "Village") find that it is in the best interests of the Village to continue with past practices of inaugurating newly elected Village officials during the first regular meeting of the Corporate Authorities in the month of May immediately following the election at which the officers were elected;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

SECTION 1: The statements set forth in the preamble to this Ordinance are true and correct and are incorporated as part of this Ordinance.

SECTION 2: The terms of the Village's elected officers shall commence at the first regular meeting of the Village's corporate authorities during the month of May immediately following the regular municipal election at which such officers are elected.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law. If any provision of this Ordinance is held invalid by a court of competent jurisdiction, that provisions shall be stricken from this Ordinance and the remaining provisions shall continue in full force and effect to the extent possible.



ORDINANCE NO. 08-63

**AN ORDINANCE CONCERNING THE SALARIES OF THE VILLAGE OF SAUK
VILLAGE'S ELECTED OFFICERS**

WHEREAS, Section 3.1-50-10 of the Illinois Municipal Code (the "Code") authorizes the Mayor and Board of Trustees (collectively, the "Corporate Authorities") of the Village of Sauk Village, Cook and Will Counties, Illinois (the "Village") to fix by ordinance the salaries of the Village's officers who hold elective office for a definite term; and

WHEREAS, pursuant to Section 3.1-50-10 of the Code, such salaries shall be fixed at least 180 days prior to the beginning of the terms of the officers whose compensation is to be fixed; and

WHEREAS, at the consolidated election to be held on April 7, 2009 (the "Election"), the offices of the Village's Mayor, Clerk and certain Trustees, each of which said offices is held for a definite term, will be filled; and

WHEREAS, pursuant to Section 3.1-10-15 of the Code and Village Ordinance No. 08-62, the terms of the individuals elected to the offices described in the preceding paragraph will commence at the first regular meeting of the Corporate Authorities held in May 2009, said date being more than 180 days after the date of adoption of this Ordinance; and

WHEREAS, it is in the best interests of the Village to fix the salaries of the Village's Mayor, Clerk and Trustees in the manner set forth below;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Sauk Village, Cook and Will Counties, Illinois, as follows:

SECTION 1: The statements set forth in the preamble to this Ordinance are true and correct and are adopted as part of this Ordinance.

SECTION 2: Beginning with the terms of the Village's elected officers that will commence at the first regular meeting of the Corporate Authorities during the month of May 2009 (the "Effective Date"), the salaries of the Village's Mayor, Clerk and Trustees shall be as follows:

- (a) The Mayor's annual salary shall be:
 - i.) \$17,000 from the Effective Date through April 30, 2010;

- ii.) \$18,000 from May 1, 2010 through April 30, 2011;
- iii.) \$19,000 from May 1, 2011 through April 30, 2012; and
- iv.) \$20,000 from May 1, 2012 through the end of the four-year term of office commencing on the Effective Date.

(b) The Clerk's annual salary shall be:

- i.) \$14,000 from the Effective Date through April 30, 2010;
- ii.) \$15,000 from May 1, 2010 through April 30, 2011;
- iii.) \$16,000 from May 1, 2011 through April 30, 2012; and
- iv.) \$17,000 from May 1, 2012 through the end of the four-year term of office commencing on the Effective Date.

(c) The Trustees shall be compensated for each meeting of the Corporate Authorities actually attended, as follows:

- i.) The Trustees currently holding office and whose offices are not subject to the Election will continue to receive \$100 per meeting;
- ii.) Trustees whose terms will commence on the Effective Date will receive \$125 per meeting; and
- iii.) Trustees whose terms will commence in May 2011 will receive \$125 per meeting.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law. If any provision of this Ordinance is held invalid by a court of competent jurisdiction, that provision shall be stricken from this Ordinance and the remaining provisions shall continue in full force and effect to the extent possible.


