A RESOLUTION TO DESIGNATE THE LOCAL LIQUOR CONTROL COMMISSIONER

WHEREAS, the Village of Sauk Village, Cook County, Illinois (the “*Village*”) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Liquor Control Act of 1934 (“Act”) provides that the mayor or president of the board of trustees is the local liquor control commissioner charged with the administration of the Liquor Control Act and the local ordinances or resolutions enacted relating to alcoholic liquor; and

WHEREAS, on November 13, 2012, former Sauk Village Mayor David Hanks designated Sherry Jasinski as the deputy local liquor control commissioner to perform the duties and responsibilities of the Local Liquor Control Commissioner under the Act; and

WHEREAS, current Sauk Village Mayor Derrick Burgess will serve as Local Liquor Control Commissioner for the Village without the assistance of a Deputy Local Liquor Control Commissioner; and

WHEREAS, the Village Mayor and Board of Trustees find that it is in the best interest of the Village to eliminate the position of Deputy Local Liquor Control Commissioner and further provide the all duties and responsibilities of the Local Liquor Control Commissioner under the Act shall be performed by Mayor Derrick Burgess as further provided below;

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Sauk Village, Cook County, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The Corporate Authorities find that it is in the best interests of the Village to eliminate the position of Deputy Local Liquor Control Commission which was held by Sherry Jasinski and further provide that Mayor Derrick Burgess shall be the Local Liquor Control Commissioner for the Village and shall be charged with the administration in the Village of the appropriate provisions of the Liquor Control Act, 235 ILCS 5/4-2, and of such ordinances and resolutions relating to alcoholic liquor as may be enacted by the Village.

Section 3. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 4. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 5. This Resolution shall be in full force and effect upon its passage, approval and publication as provided by law.
