Sauk Village and the First 30 Days

During the first thirty days as Acting Mayor I have worked with the Board of Trustees and staff to restore order and decorum to the Village Board meetings, filled the Trustee position left by the resignation of Trustee Robert Chavez, appointed two members to the Zoning Board, appointed two members to the Housing Authority Commission, reorganized the Parks and Recreation Department and was able to convince Village Auditors McGladrey and Pullen to complete and present the 2009-2010 village audit.

The Board has also taken action on my suggested cost savings recommendations that include:

• Removed Delgado Law Group as the Village's tax increment financing law firm, and replaced them with Odelson & Sterk, the current Village corporate law firm.

Result: Condensing to one Attorney firm

 Terminated Baxter & Woodman Engineering and replaced them with Robinson Engineering, the current Village Engineering firm.

Result: Condensing to one Engineering firm

• Approved Hub International, the insurance broker of record for Worker's Compensation insurance which resulted in a cost savings of over \$20,000.00 a year

In addition, bi-weekly meetings are held with Departments Heads and myself in order to receive updates and to address any concerns that require attention. I am thankful to the staff that has continued to work under the conditions of the scaling down of their departments while being forced to do more with less.

There will be at least two Town Hall meetings to explain what Electric Aggregation is and how residents will have the opportunity to opt in or opt out of the program. The Police Department has re-implemented roadside compliance and safety checks, police cars have been outfitted with new tires and Chief Stoffregen has been directed to start the hiring process of two new police officers to fill the positions of officers that have resigned.

Our Public Works Department has purchased new fire hydrants and expects to start repairing or replacing non-working hydrants mid January 2013.

I will continue to insist that the Board pass the Crime-Free Rental Housing Ordinance. Trustee Myers and the Ordinance Review Committee are in the final stages of reviewing the ordinance and expect to present the final draft to the Village Board in January, 2013.

As Acting Mayor, I promise to continue working towards healing and peace as Sauk Village moves forward, bringing order and decorum back to village Board meetings, financial responsibility, open communication, enforcement of local ordinances, bringing back "Pride and Progress" and reaching out to the business community informing them that Sauk Village is the place to build or relocate.

Fire Department News

Deputy Fire Chief Rich Atwood

A guy by the name of A. Whitney Brown said, "The past actually happened, but history is only what someone wrote down." How very true this statement is. If not for those that took pen to paper (or fingers to keyboards) though, what record would we have? We have the stories-the kitchen table talk when two or three old friends get together, the bits and pieces we gather from an old photograph. What happens when those stories are lost and the photographs faded? We wish somebody took the time to write that stuff down.

Just recently, our department secretary Donna Rooney happened upon a small gold mine. Tucked away deep in a seldom used file drawer, Donna chanced upon a three page document titled, "Sauk Village Fire Department, A History," by Assistant Chief Tom Schroeder. Assistant Chief Schroeder retired from the Sauk Village Fire Department in 2002 after 27 years of service to this community. AC Schroeder was one of those few people who took the time to write out history.

One of the things I admired about AC Schroeder's

paper was the objective approach he took. Other than penning his name under the title, there were no names mentioned- only the progressive growth of a fire department from 1957 to 1999. This paper inspired me to write the next 14 years as an addendum to AC Schroeder's work. I followed his lead and left out the names, well, except one- our late Fire Chaplain Lee Gatzke. It seemed appropriate. So, now there exists a pretty decent, chronological history of the Sauk Village Fire Department- from the "10 men and a 1934 Chevrolet fire engine," to today. The next project will be to dig up some old photos and put together a book, but don't hold your breath.

Want to become a part of history in the making? The Fire Service is FULL of history and tradition. The Maltese cross is the symbol of the Fire Service and is a badge of honor to all of those that wear it. The Maltese cross has a long history going back to the first recognized firefighters who were actually knights during the Crusades.

On March 6, 2013, a court order was issued requiring the Village of Sauk Village to continue to use temporary air stripping equipment to provide its residents with safe and clean drinking water. This concludes years of litigation between the Illinois Environmental Protection Agency ("EPA") and Sauk Village.

In 2009, vinyl chloride was detected in the Village's water system, specifically Well #3. The Village shut down Wells #3 and supplied its residents water from Wells #1 and #2. The EPA directed the Illinois Attorney General to file a compliance lawsuit against the Village in April 2010, requesting an overhaul of the Village's water system. The Village made some improvements to the water system and reviewed all options to supply its residents with the safe and clean drinking water. One option suggested by the EPA was the installation of temporary air strippers to remove vinyl chloride from the water.

During the summer of 2012, vinyl chloride was detected in Wells #1 and #2 and continued to rise to levels which required the Village to send notices to its residents and businesses. Residents were advised not to consume water from Wells #1 and #2 and bottled water was distributed by the Village. In August of 2012, temporary air strippers were installed with the assistance of multiple state agencies, and the Village has provided safe and clean water and continues to do so today.

The Village is in the process of purchasing and installing permanent air strippers to provide safe and clean water for years to come. The Village's long term plan is to obtain Lake Michigan water. This is only possible after major infrastructure improvements can be made to the water supply system. The Village's plan to install permanent air strippers, repair the Village's leaking water supply lines and other infrastructure work has been reviewed and approved by the EPA. The Village's approval plan is contained in the March 6, 2013 court order.

The EPA lawsuit carried a potential fine of \$50,000 per count of the Complaint, plus a maximum fine of \$10,000 for every day the violations existed. The Village fines could have easily exceeded \$1,000,000 based upon the length of this litigation. In concluding this litigation the Village has agreed to pay a fine of \$2,500, a significant savings to the Village and its taxpayers.

The resolution of this complex matter was made possible by the cooperative efforts of our consultants, Village Attorney Odelson and Sterk, Village Engineer Robinson Engineering, and the Illinois Attorney General's Office.

Village Water System Update

Sauk Village is conducting a three-phase plan for improvements to the water system infrastructure:

Phase 1 – Construct Improvements to the Existing Water Treatment Plants

Phase 2 – Implement Water Distribution System Repairs and Replacements

Phase 3 – Acquire Lake Michigan Water

Below is an update on the progress the Village has made on this plan.

Phase 1 – Water Treatment Plant Improvements

The IEPA has issued an opinion that the proposed water treatment plant improvements project is the quickest and most cost effective means to returning Sauk Village's water system to water system to compliance with IEPA standards. With just a few items left to complete on the loan application, it appears likely that the IEPA will issue a loan to Sauk Village for the project. When completed the project will provide water that is safe and of sufficient quantity for the Village's water users. New air strippers to remove the vinyl chloride will be installed; the current aged iron filters will be replaced with new equipment and filtering media; and various other site improvements will be completed.

The IEPA issued a construction permit for the project in June. The project was advertised for bid in early August, and bids from contractors will be opened at the October 8th Village board meeting. Once the project is awarded, the contractor will have one year to complete the work. The Village has met the compliance schedule deadlines listed in the Illinois Attorney General's consent order.

Phase 2 - Water Distribution System Repairs and Replacements

The Village hired a firm to conduct a leak detection survey to pinpoint the major leak locations in the distribution system. Fourteen leaks were detected during the field investigations conducted this past summer. Public Works staff has since repaired two of these leaks and will complete repairs of the remaining defective infrastructure in the coming months.

Phase 3 – Lake Michigan Water

Once water loss is reduced to less than 8%, Sauk Village will submit another application to the IDNR for Lake Michigan water. It is anticipated that the IDNR will view Sauk Village's application more favorably with minor system water loss, and it is hoped that the IDNR will grant the Village's request to receive Lake Michigan water.

With an approved Lake Michigan water allocation, Sauk Village will then move forward with the design and construction of the required water infrastructure improvements (supply water main, pump station, and storage tanks). Funding for these improvements would have to be determined, and a water rate increase would likely be required.

Mayor's Corner

I am pleased to share with the residents a recent positive development for the Village's industrial community. The Village through its TIF team has been working with developer VHE II-Sauk, LLC over the last six (6) months in order to facilitate the almost \$17,000,000 purchase and development of a 496,260 square foot building.

VHE II-Sauk, LLC entered into a real estate purchase agreement for the property with plans to make substantial improvements in order to operate the building as a warehouse distribution facility. On Tuesday, October 25th the Village finalized the Redevelopment Agreement with VHE II-Sauk, LLC when the board passed a resolution to approve the agreement at the regular village board meeting. This resolution aids in the completion of the property improvements and to ensure growth in the Village's industrial district.

Incentives were required in order to bring this development to Sauk Village and the Village's TIF team met with several state and county agencies to facilitate this development and agreement. The improvements include a rail spur, additional rail siding, truck spots, truck doors and parking lot enhancements. This development will result in additional job opportunities within the Village as well as increased tax revenues within the district. It also provides the Village an opportunity to highlight the advantages of the Village industrial center to businesses the Village is currently meeting with as well as future developers.

I would like to thank the Village's TIF team for working with the state and county on this agreement, including Former Mayor Ed Paesel, Kane, McKenna and Associates, Inc and Odelson and Sterk.

VHE II-Sauk, LLC is a reputable business whose continued presence within the Village's industrial community is expected to stimulate and strengthen the Village's business environment. We look forward to a continued relationship with VHE II-Sauk, LLC and wish them success with their project and improvements.

Fire Department News

Deputy Fire Chief Rich Atwood



I'm going to title this month's article "Welcome to the suburbs." I'm want to take this opportunity to clear up a few common misconceptions regarding the difference between big city fire departments, i.e. Chicago, and suburban departments like Sauk Village and many of our surrounding neighbors.

Misconception #1: The Sauk Village Fire Department is staffed 24/7/365- NOT TRUE. Like many suburban departments in our area, we are predominately Paid on Call. That means our firefighters have other full time jobs. When a 911 call comes in for the fire dept, our personnel are notified via pager. If they are available, they respond. We do have one part-time shift 7 days a week from 6am to 6pm. This is statistically our highest chance of having calls. The shift is intended to guarantee an apparatus driver/operator.

Misconception #2: The Sauk Village Fire Department has to have other towns come in to fight their fires for them (and that's a direct quote)- also NOT TRUE. The Chicago Fire Department staffs 100 fire stations with a wide variety of equipment and about 5000 firefighters and staff (Wiki-answers.com). When they have a working house fire, Chicago automatically sends 2 fire engines, 3 fire trucks (yeah, there's a difference), 1 rescue squad, 3 chiefs and an ambulance. All these vehicles come from 3 or 4 different fire stations, but yes, they all say "CFD" on the side of the vehicle. In Sauk Village, when dispatch receives a report of a working fire, they automatically dispatch 4 fire engines and an ambulance- not that much different from Chicago. The big difference being that our four fire engines are going to say Sauk Village, South Chicago Heights, Crete, and Crete Township on the sides. We all work and train together to provide you with a better service. Sauk Village Fire Department likewise responds to these communities for their fires.

Misconception #3: The Sauk Village Fire Department will hire anybody- ALSO, not true. Granted, you don't have to have any prior experience, BUT to even be granted an interview, you must positively answer these five simple questions: 1) are you 18 or older; 2) do you have a high school diploma or GED; 3) do you live within Sauk Village; 4) do you have any felony convictions; and 5) do you have a valid driver's license? Once these questions have been answered satisfactory, then we'll have the chat called "this job won't pay your bills or support your family" followed by "what are you hoping to get out of this?" Then I lay out the expectations: weekly training requirements, call participation requirements, state firefighter certification. Then I explain that last item. For 16 weeks out of your life, you will attend the Fire Academy through Prairie State College. Two

week nights and every Saturday for those 16 weeks you will be in class or performing hands on skills. In between those times, you will have your nose in a book studying. Assuming I haven't scared off the applicant by this point, and we agree that our hopes and expectations are aligned, I will send the applicant for a back ground check. If that comes back favorably, the applicant will be sent for a full blown, no non-sense medical physical. Only after that comes back clear will the applicant be sworn in as a Sauk Village firefighter- then the real adventure starts. Just ask my 7 new recruits that are in the middle of the Academy now- they'll tell you ALL about it.

On the subject of new recruits, of the five pre-requisite questions, we lose the most applicants over the residency requirement, and even more because of felony convictions. That's not even our rule- that's Illinois law to be a firefighter, so stay out of trouble if you want to head in this direction some time.

And finally, Misconception #4: The Sauk Village Fire Department gives out free smoke alarms- this too is incredibly NOT TRUE. A couple of times a year, there'll be a news story where Chicago is giving out free smoke detectors and I know the phone is going to start ringing. We do not get smoke detectors for free, and I'm sure Chicago doesn't either, but however Chicago manages this, we don't have that resource. Now from time to time, we have bought just a few detectors to give away as prizes at one of our public events, but that is the extent of it. It's just not fiscally feasible for us to supply smoke and/or carbon monoxide detectors.

I do sincerely hope that this article has helped you to better understand how we function and why we function the way we do. And it's not anything special to Sauk Village. Many of our neighbors work this way as well, with the exception of having dedicated staff around the clock to run ambulance calls, but that's not an issue for us.

These were just 4 of the biggest misconceptions that I've heard. Seriously, if you have any questions of your own, I am more than happy to sit and chat with you. There's no need for FOIA requests or blurting on Facebook- just give me a call at 708-758-2225 or email me at richresq1@comcast.net.

I am also happy to report the Police Department has been awarded the Bullet Proof Vest Grant, the STEP Grant and the Police Department also has been awarded a new Breathalyzer instrument. The Breathalyzer alone will save the village approximately \$7,000.00. I would like to thank members of my administrative staff for their hard work and dedication in getting these grants approved.
