- **Roads repaired throughout the village –** Yes, there are still more streets that need to be repaired and less streets will be repaired this year due to lack of funding coming out of Springfield for road repairs in 2016 and possibly 2017. However, we will continue to be an advocate for the residents of Sauk Village down in Springfield.
- **New energy efficient street lights** Sauk Village will have new street lights throughout the entire village with an estimated completion date by the end of the second quarter. When elected Mayor, non-working street lights was one area of complaint among village residents.
- Safe walking path across 394 & Sauk Trail Providing safety for families and youth that must walk or ride their bikes to neighboring communities or Bloom Trail High School is a concern. In addition, we are currently in discussions with State, County and adjacent communities to use shared resources to have the path extended to Cottage Grove and then South to Mary Byrne Drive.
- Removal of Blight The Sauk Village Housing Commission in conjunction with the Sauk Village Police Department and Cook County Sherriff's office has been aggressively attacking blight through the removal of vacant and dilapidated homes. In addition, they have been identifying vacant homes through the vacant home sticker program. This not only improves the image of our community but also helps with reducing crime in what was once high profile areas.

**Reduction of the deficit** – Sauk Village's deficit has been reduced every year during this administration. While we continue to face financial challenges we also continue to provide services for residents.

Improved Policing - In just his short tenure in Sauk Village, Police Chief Robert Kowalski, who came with a wealth of knowledge and experience, has made the professional and positive changes within the department that had been lacking for some time and the stats speak for them self

Reduction in crime - For the 1st two months of 2016, UCR Reported Crime has dropped 54% over the same period in 2015.

Intergovernmental cooperation between the Sauk Village Police department and State and County agencies

- Ongoing working relationship with the States Attorney's Office to make needed arrest and closure to crimes. Since Chief Kowalski has been on board complaints against the department have decreased and residents are praising the officers and the department for a Job Well Done!

While there is positive growth, there are still challenges we face. While these challenges come in no order they are all just as equally important to Moving Sauk Village Forward.

- Sauk Village Annual Budget As we go into another year we struggle to present a balanced budget due to the uncertainty in Springfield. I'll be presenting to the board a worse case scenario budget for a second year in a row. We'll do our best to continue to provide services, however, Sauk Village has always provided the majority of its services through volunteers and donations. This can be seen through events such as the village wide clean up days, corn and dog roast, Santa parade, 4th of July events, Christmas food and toy outreach, etc. This year will be no different and we'll continue to look to the residents to volunteer.
- The Lack of a State of Illinois Budget The State of Illinois has yet to pass a budget. This effects Sauk Village's budget and ability to plan and project revenues that our budget and departments are dependent upon.
- **Divided Village Board** This goes along with the next couple points. When elected, we were elected for all of the residents. It's ok to disagree however, it hurts the village to be disagreeable. Rather than focusing on the negative in the world, let's try counting our blessings, start looking at the positive around us and work together for all the residents of Sauk Village.
- Upcoming election year Sauk Village needs a board that will work towards Moving Sauk Village Forward. Join with me and contact your local village board members and tell them to "Stop the Politicking, Start working together, and Move the Village Forward!" We have enough division in Springfield and Washington we don't need it in Sauk Village
- Reduction or NO grant (CDBG) funds in 2016 or 2017 This is a resource that communities depend on for street repairs. Without these funds no major road repairs will be made this year or next. We will continue to work with our State and County representatives on behalf of the village and its residents and let you know if anything changes.

#### What do you need to Early Vote?

1. Voters do not need to provide an excuse or reason why they cannot vote on Election Day.

<u>**Government-issued photo ID is not required**</u> but is helpful if there is a question about the voter's registration, address or signature. Providing an ID can also speed up the process because we have ID card readers at every check-in station.

You can Register to Vote at ALL Early Vote Sites. NOTE: Any voter who needs to register for the first time or file an address change or name change must present two forms of ID, one of which shows the voter's current address.

## Voting equipment

Early Voting is conducted on touch screens that store every ballot style in the county, permitting any voter in suburban Cook to vote at any location.

#### **Ballot secrecy**

Your ballot will remain secret and securely stored.

#### Early Voting records

The names of the early voters are available to the public and are updated each day during Early Voting. Please call (312) 603-0900 for early voting information.

#### In-person voting only

Voters who participate in Early Voting must vote in person.

# Grace Period Registration and Voting: Suburban Cook County February 17 - March 14, 2016

# March 15, 2016 Presidential Primary Election

Grace period registration and voting extends the registration period by allowing voters to register and vote until the Monday before an election. Guidelines limit when and where grace period registrants can vote. During grace period registration, voters must register and vote in person at one of the locations listed below.

Individuals wishing to vote during the grace period must bring <u>two pieces of identification</u> to register. Grace period registrants immediately cast their ballot after registering to vote.

# **Voter qualifications**

To register to vote, you must be:

1. A U.S. citizen

At least 18 years old by the general election

A resident of your precinct at least 30 days prior to Election Day

You also must display two pieces of identification. Neither needs to be a photo ID, but one must include your current address. Acceptable forms of ID include:

- Illinois driver's license
- Illinois state ID
- Employee or student ID
- Credit card
- Social security card
- Birth certificate
- Utility bill in applicant's name
- Mail postmarked to the applicant
- Valid U.S. passport
- Public aid ID card

Lease or rental contract

In Illinois, you do not declare affiliation with a political party when you register to vote. In primary elections, you may choose to vote a specific political party ballot on Primary Election Day.

# **Disabled Voter Program**

If you are permanently physically incapacitated and unable to make it to your polling place, you qualify to automatically receive an application for a mail ballot before every election for the next five years.

#### To sign up, you must:

#### Be a registered voter

Submit a notarized Disabled Voter Program application completed by you and your doctor. If you haven't already applied to vote by mail, the Clerk's office will send you a <u>mail ballot application</u>. For more information:

# **Overseas and Military Voters**

Suburban Cook County voters who live overseas or are serving in the U.S. Armed Forces may register to vote and apply for an absentee ballot by completing a Federal Postcard Application (FPCA). The FPCA is current for one calendar year and ensures that the voter will automatically be sent an absentee ballot for each election held in that year. Ballots and election materials are sent by mail, email or fax, whichever method the voter indicates on the application.

#### The following categories of voters are eligible to use the Federal Postcard Application (FPCA):

• U.S. citizens who no longer maintain a residence in suburban Cook County but lived there immediately prior to relocating abroad\*

• Members of the U.S. Armed Forces and their spouses and dependents stationed in the U.S. or abroad and whose last civilian address was in suburban Cook County\*

U.S. citizens whose permanent residence is in suburban Cook County but will be temporarily residing abroad on Election Day\*

\* In all of these instances, you are eligible to vote absentee even if you are not currently registered. Your Federal Postcard Application will serve as a registration application as well.

# Step 2 - Mail in the application

**MAIL** in the application. If you submit the application by email or fax, you must still mail us a signed hard copy, but taking advantage of the email or fax option will expedite delivery of your ballot.

# Step 3 - Ballot will be delivered

**BALLOT** will be delivered by email or mail, depending upon which option you chose when you completed the application.

# Step 4 - Vote!

**VOTE!** If you received the ballot by mail, follow the instructions in the Mail Voting instructions brochure you received. If you received an email, follow the instructions within the email or access your ballot at <a href="https://cookcountyclerk.everyonecounts.com">https://cookcountyclerk.everyonecounts.com</a>, a secure website where you can log in, vote your ballot online, print your voted ballot and print the accompanying ballot materials.

# Step 5 - Email or mail your ballot

All voted ballots and certification documents must be returned to the Clerk's office by mail, even if you received it by email or fax.

# **Nursing Home and Hospital Voting**

#### Nursing home voting

The Clerk's office conducts voting at suburban Cook County nursing homes before every election. Call the Clerk's office at (312) 603-0929 for more information. <u>A list of nursing home voting locations for the March 15, 2016 Presidential Primary Election is available here</u>.

## Hospital/Nursing Home/Rehabilitation Center Voting

If you are admitted to a hospital, nursing home or rehabilitation center fourteen days or fewer before an election, you may arrange to have a ballot delivered to you at the hospital.

You and your doctor must complete and sign a legal affidavit that serves as an application form and arrange to have it delivered to the Cook County Clerk's office. The Clerk's office will issue you a ballot at that time and give it to a relative (spouse, parent, child, brother or sister) or another registered voter of the same precinct who will bring it to you at the hospital and then return it to the Clerk's office after you make your selections. The individual delivering the ballot on your behalf must sign the affidavit accompanying your ballot application.

Completed ballots must be delivered in person to the Clerk's office (69 W. Washington St., Room 500, Chicago) before 7 p.m. on Election Day.

# Vote By Mail

Any registered suburban Cook County voter may request a mail ballot using the online application found at www.cookcountyclerk.com.

Once your registration is verified and your application is processed, the Cook County Clerk's office will send a paper ballot to the mailing address you designate in your application. The deadline to apply, including email verification, is five days before an election. To complete an online mail ballot application, you will need:

- an email address
- your driver's license or state identification number
- the last four digits of your Social Security Number
- and the address where you would like your ballot mailed

If your driver's license/state ID or your Social Security number is not on file, you will not be able to complete this application online unless you update your voter registration by calling 312.603.0946. Incomplete registrations are most common for voters who have been registered at the same address for 20 years or more.

Ballot Integrity: Unless you require assistance, do not let anyone else mark your ballot; do not let anyone force or coerce you into voting for any candidate; and do not let anyone, other than a close relative or authorized messenger, mail, deliver or handle your voted ballot.

Please note: Making a false statement to obtain a mail ballot or soliciting someone to do so is considered vote fraud, a criminal offense punishable by up to five years in prison. Call 312.603.0909 to report vote fraud.

## **Download a Mail Ballot Application**

If you do not have one of the online application requirements, or if you prefer to apply on paper, you may download, print and sign a mail ballot application and send it to the Cook County Clerk's office.

Apply as early as possible to make sure you receive your ballot in time to vote. Your ballot must be postmarked no later than Election Day and received at the Cook County Clerk's office within 14 days after Election Day.

If you apply using a paper form, the Clerk's office will verify your eligibility and compare the signature on your application against the signature on your voter registration record before issuing a ballot. If you apply online, the system verifies your eligibility with the data you provide. Regardless of how you apply, the signature on your ballot will be compared against the signature in your voter file before your ballot is counted.

## **Police Department**

Police Chief Robert Kowalski

The primary focus of the Police Department is providing a safe and secure environment for the residents and their guests. In light of this the police department continues to work with JW Fairman, Village Administrator, Gary Holcomb, Chairperson for the Sauk Village Housing Commission, Sherry Jasinski, Director of Administrative Services and Sue Dobrzeniecki, Code Enforcement Officer on the Blue Print plan of ridding blight created by the abandoned and burnt out homes located around the Village. In addition we have enjoyed a close relationship with the Cook County Sheriff's Office and will continue to utilize them as a resources that they have made available to the community in assisting our efforts.

Many citizens have been wondering why we have been putting green stickers on home identifying them as vacant homes. This was just the beginning of a bigger plan in identifying and notifying owners that something needs to be done to these properties. The next step has already taken place and the Police Department has now placed "Do Not Enter" sticker on the identified homes that were listed as being vacant. You might be wondering why point out the obvious and the answer is to provide a warning that squatting in these homes or breaking into the homes will not be tolerated.

We are now going to the next phase which entails going to vacant homes or homes that should be vacant because there is no occupancy permit and or a water account and determine if someone is actually living at that location. We have found that there are people not paying for water or garbage pickup service. This plan is part of being fiscally responsible and providing the best possible service to the citizens of Sauk Village.
