With the exception of plumbers and irrigation contractors, all contractors shall provide the following:

- Completed Registration Form
- Copy of Driver's License
- Proof of Insurance: Bodily injury liability - \$300,000; Property damage liability - \$100,000
- Business Automobile - \$300,000; Worker's compensation insurance (If applicable)
- Surety Bond (Village of Sauk Village named as certificate holder) \$10,000
- Registration Fee (See table below)

Electrical Contractors must also provide:

• Copy of electrician's license that required passage of a written test based on the Chicago Electrical Code or National Electrical Code and administered by one of the following municipalities; Chicago, Deerfield, Des Plaines, Downs Grove, Elgin, Glenview, Kankakee, Lansing, Libertyville, Matteson, North Chicago, Orland Park, Ottawa, Schaumburg, Streamwood, Waukegan, Wilmette or Zion.

Roofing Contractors shall provide a copy of their State of Illinois roofing license.

Plumbing and irrigation contractors shall provide a copy of their State of Illinois license.

All contractor registrations expire on April 30th of the following year.
