4. DISCUSSIONS & PRESENTATIONS

The agenda was changed to include items in the following order

Attorney Megan? spoke on the petition for disconnection by a business and the confusion of
the street address located at Route 30 to annex to Ford Heights. The impact to the Village was
discussed, along with the infeasibility of the request as the parcel requested to disconnect is in
between two other Sauk Village's properties. It was decided that, though the premise was not
beneficial to the Village, it would be on the next Board agenda for consideration for adoption.

- Village Administrator Timothy Williams
 - O A Resolution Approving an Economic Development Consulting Proposal and Authorizing the Execution Of A Professional Services Agreement By and Between The Village of Sauk Village and Southland Development Authority. This item was not presented as it lacked readiness
 - A Resolution Approving and Authorizing the Execution of a Professional Services Agreement for Accounting Services By and Between The Village of Sauk Village and W & W Consulting Group, LLC
 - The Services and topic were discussed as a mechanism to assist with the overdue audits. Mr. Williams, the current Interim Treasurer's firm, W & W Consulting Group would provide two financial consultants to help with the audits. The scope of their work was presented.
